MANAGEMENT: The Races are under management of the AYC Board, which shall have final authority to establish racing conditions and interpret the racing rules under USSA.

ELIGIBILITY: Series race is open to all sailing yachts owned by AYC members or their spouses who have paid their race fees and file within the prescribed class rules, and non-members by invitation or through application of individual members of clubs or associations which are members of ABYRA or DYRA. Jam boats may race one season without club affiliation. AYC Management reserves the right to accept or deny any applications.

RATINGS: Boats will be assigned a rating as determined by their current DRYA Certificate. If a boat does not have a certificate, the AYC Race Board will assign a rating based on comparable boats on the DRYA valid list. If no similar boat is available, a rating will be assigned by the AYC Race Board based on the most recent available information. If a new rating is assigned to a boat during the season, the rating will only apply to remaining races. No new credits or favorable rating changes will be applied without a valid current DRYA-PHRF certificate.

SCORING: Best 5 out of 7 races for each series will be scored to determine series standings. Best 10 out of 14 races will be scored for Season Overall standings. In the event of an abandoned race or races, the number of races needed to qualify will be reduced by the number abandoned races. You must qualify in both Spring & Summer series (in the same class) to qualify for Season Overall.

AWARDS: Skippers registering for both Spring & Summer Series will receive a participation award. Results and/or awards will be presented following each race in the series. Awards will be given for designated flag races. Series flags will be given out following the final race of the series.

SEASON OVERALL: Flags for Season Overall will be given out at the **ABYRA** Haul-Out party. Refer to the 2011 ABYRA Racing Handbook for the location and time of this party.

SKIPPER'S MEETING: A pre-season skippers meeting will be held at the North Star Sail Club on Friday, April 29th, 2010 at 7:00pm. **This meeting is Mandatory.** Race instructions shall be issued at this meeting.

Committee boat assignments will be made at this meeting.
The registered yacht shall not race when the skipper is assigned Committee Boat Duty. Skipper must serve Committee Boat Duty or be disqualified.

CLASSES:

Spinnaker - All Legal sails

Jam - No Spinnakers or nylon head sails. Double Headsails are not permitted (unless allowed & noted in valid DRYA Certificate.) Spinnaker or whisker poles may not exceed J-dimension.

Asymmetrical - Mackinac Cruising Class rules excluding sport boats.

RULES: The races will be sailed under current USSA Racing Rules except as modified by these instructions.

STARTING SYSTEM: As stated in the Racing Rules of Sailing 2009-2012, Part 3 - Conduct of a Race, Rule 26, Starting Races. Class splits will be posted at North Star Sail Club prior to the first race.

RESTRICTED AREA: All yachts must keep clear of the starting area and of the first leg of the course until after the preparatory signal for their class.

TIME LIMIT: Three (3) Hours for each class (one yacht finishing within the time limit constitutes a race for its class and extends the time limit for its class).

ABANDONMENT OF RACE: Yachts dropping out shall report as soon as possible to the committee boat, in person or by contacting them on VHF Channel 72.

Insurance: AYC Requires that all yachts are insured for all races.

COURSE: ABYRA triangle with the Clinton River Buoy "CR" being the Start/Finish Buoy, length 6 statute miles, 5.2 nautical miles (approximate). If wind conditions warrant and the Race Committee deems necessary, an alternate course will be an up and back between Clinton River Buoy "CR" and the racing mark "C, A, B, or 1PH". Designation of these courses will be signaled by the Race Committee flying a white cylinder with a black letter "C, A, B, or 1".

Approximate Mark Positions are:

"CR"	42° 35' 57"	82° 44' 51"
"A"	42° 37' 42"	82° 46' 00"
"B"	42° 37' 16"	82° 43' 65"
"C"	42° 38' 60"	82° 44' 75"
"1PH"	42° 32' 47"	82° 44' 47"

(actual mark positions will be reported at the ABYRA Skippers meeting on April 30th)

START/FINISH: All classes will start and finish between RC flag on the Committee Boat and the "CR" buoy, except for shortened courses which will end between nearby mark and the Committee Boat. The RC Boat will be moved after the start.
